Maywood Public School has the option to lease the computers or buy more additional computers. She also spoke about the schools options for the teachers' computers whether to lease or buy them out. E-Rate funds should cover the majority of the cost. The school is also looking at some interactive projectors for 3 of the classrooms.

Mr. McCain spoke to the Board about elementary and high school parent attendance for parent/teacher conferences. The elementary attendance was nearly 100% and the high school was about 70%. He also spoke about attendance and unexcused absences. Mr. McCain explained unexcused absences and how they are counted and how parents are notified. The high school math position has been filled. Girls State Basketball will be somewhat different this year. If MHC makes the state tournament the team will play on Wednesday at Lincoln North Star High School.

d. Superintendent report

Mr. Bejot spoke to the Board about the bus parking. The buses are being parked on the old tennis court currently. Part of the cement has collapsed where the drain is. Mr. Bejot is going to call and try to get and estimate to get it fixed. NASB Spring Conference will be virtual and the NRCSA Spring Conference will be in person in Kearney. Mr. Bejot also gave an update with the HVAC progress. Building and grounds committee will try to meet the week of February 15 to discuss moving forward with the HVAC process. He also spoke about the LB 408 legislative issues and how they would affect small schools. The school's new suburban is finished and has been delivered to the school.
